

Zero Tiger Poaching reported due to the protective measures and vigilance.

3. Compared to 2018, reduction of 45.94 % burnt area reported in 2019.In 2019, 218 fire incidences occurred burning 2206.939 ha ie.2.78% of total area. In 2018, 265 incidences occurred burning 4803.62 ha ie. 6.05% of total area.



करीता नविन अतिक्रमण होणार नाही याकरीता कर्मचारी स्टॉप जाणार आहे. करीता वरील प्रमाणे परीस्थिती पाहता नविन अतिक्रमण रोखण्याचे दृष्टिने व परीस्थिती नियंत्रणात आणणे करीता आपले स्तरावरुन पुढिल आदेश होण्यास विनंती आहे. करीता माहितीस व पुढिल आवययक कार्यवाहिस सविनय सादर.
