Some Questions, Issues to ponder over...

- Forests and wildlife laws <u>How Just in Framework and Operation? State, Capital and Community</u>
- Relevance and effectiveness of the provisions of these laws? Have these undergone reforms with the changed circumstances?
- ☐ Laws and legal systems always lag in adaptation with changing social setting and context;
- Adaptation, reform or transformation of the legal system of governance and administration of forests and forestry, and environmental protection

Too much time lag in some areas? Better late than never!

Certain provisions in Indian Forest Act 1927 have:

- Outlived their utility;
- Incompatible to Changed Realities / Disconnected to Contemporary Needs;


- Issues of reform in Forest Acts (1927, 1980) and Wildlife Act (1972):
 - Decriminalization in some categories of offences
 - □ "Forest produce" definition *monopolistic and exclusionary coverage still required*?
 - ☐ Incorporation of eco-system values and functions in legal framework
 - ☐ Inclusion of river, aquatic and wetland eco-systems, habitats and landscapes in Wildlife (Protection) Act 1972
 - ☐ Incorporation of enabling elements related to other later acts:
 - ♦ Biodiversity (Conservation) Act 2002
 - ♦ Pollution and Environment Protection related acts (1986)
- Integration, Convergence and Cohesiveness among laws, rules and legal and enforcement systems *Daunting task*

Some Questions, Issues to ponder over...

Operation of laws, rules and legal systems:
☐ Deficits and deficiencies
☐ Imbalances and Bias in enforcement and implementation —
Non-implementation or delayed implementation of certain sections — Decades of delay in enquiry and settlement of rights etc. — vitiates the law, creates anomalies, social stresses and adverse social reactions, agitations
☐ Mechanical implementation — Rule orientation vs. objective orientation
☐ Presumptive and safeguarding provisions unduly weighed in favour of State vis-à-vis local community
☐ State, Capital, Community – Balancing the stakes, influence
Instances:

- ♦ Why did we have to have Sch. Tribes & TFD (Recognition of Forest Rights) Act in 2006, six decades after independence?
- ♦ Why should villages within boundary of a sanctuary cannot have *pucca road access* without permission under FC Act 1980 and/or Wildlife Protection Act?

- Operation of laws, rules and legal systems:
- ♦ Have the law and legal system related to *forests and wildlife* been <u>Unjustly Biased</u> against and <u>Oppressive</u> for the Weaker Section of the society?
- **♦** Why did we have to have Sch. Tribes & TFD (Recognition of Forest Rights) Act in 2006, six decades after independence?



State includes – Legislature, Executive & Judiciary - all three are fallible, biased and imperfect

- Contribute to transformative changes in legal framework and operational system with insightful observations from ground level, interfaces with community and other stakeholders and experiences with processes in the field and their outcomes, events of failure and success related to operation of laws and rules

Challenging roles, opportunities and functions....2

- Balancing of *humane approach* towards deprived section of private individuals and local community and harsh disposition of laws on forests and wildlife;
- Contribution to reforms in operation of laws dialogical approach with Courts on one hand and legal representatives State Counsels on the other *Differential approach*
- Find and occupy appropriate operational roles and functions in *emergent arenas* of administration, governance, law and policy in subject areas with implications for Environmental and Ecological dimensions many a time beyond forests and wildlife by pro-active disposition, initiatives and innovative approaches.
